### Report:

This project was first requested by the Sambhota Tibetan School, Miao as they have very limited resources available to them. In addition to that, being located in the remote areas of North East part of India, very less development took place. With the kind financial support from TCEF (Tibetan Children's Education Foundation, USA. We received a sum of Rs 58,150/- (after deducting 4% admin charges). The amount was sent to the school Account for project implementation.

Pre-primary teachers were asked to provide a list of what teaching aids they wanted. From their list we selected the items which could be bought for this sum of money. We have asked the Department of Education (Central Tibetan Administration) to give a recommendation for a company which could provide teaching aids materials. The Education Officer, Mr. Nygodup Tenpa suggested a company in Bangalore called **Kidken Edu Solution**, a supplier of teaching aids. We gathered the quotation within the limits of the project funds, inclusive of transport. They did so efficiently and we received the material on 4<sup>th</sup> of November, 2017. The material has been handed over to the pre-primary section. A total of 94 children will be benefitting from these teaching aids.

In the below listed photos, we couldn't keep those in shelves as the current pre-primary school is in renovation stage of extension and will be completed within this month. In the meantime, students are shifted to settlement hall temporarily.

The pre-primary teachers were very happy and we wholeheartedly thank the TCEF (Tibetan Children's Education Foundation), USA for this generous gift. This has provided essential teaching aids for the Kindergarten section, which had been very poorly equipped to date. The teaching material have brought a broad smile on the children's face.
